The property is located at 5,000' elevation on the north side of Monashee Creek some 38 miles east of Vernon.

The showings were staked in 1903 by S. Hill and J. Chamberlain of Revelstoke, as the Silver Bell, Stult and Joe Chamberlain claims. Work at that time included trenching and about 80' of drift adit.

The ground was restaked in 1914 by W.J. Bell and associates as the Silver Bell, Silver Horde and Silver Moon claims. At time of reporting the adit had been extended to 140'. The Silver Horde claim was Crown-granted to G. Severidge in 1920 and the Silver Bell (Lot 4329) to Amelia Bell in 1921.

Cheyenne Mines Ltd acquired the property in 1977 and some ore was shipped in 1978.

#### HISTORY OF PRODUCTION/HISTORIQUE DE LA PRODUCTION

In 1978, 14 tonnes of sorted ore were shipped. From this ore 311 grams gold, 43 171 grams silver, 700 kg lead, and 252 kg zinc were recovered.
