DESCRIPTION OF DEPOSIT/DESCRIPTION DU GISEMENT

Rocks in the vicinity of the Silver Zone include mafic volcanics, greywackes and sandstone of the Devono-Mississippian Eagle Bay Formation. Disseminated and massive sulphide mineralization, with an average width of 2.7 m, lies along the contact between chert and tuffaceous sediments within the Eagle Bay Formation.

HISTORY OF EXPLORATION AND DEVELOPMENT HISTORIQUE DE L'EXPLORATION ET DE LA MISE EN VALEUR

The showings are located at approximately 3800 feet elevation on the east side of Johnson Creek, 9 km north-north-west of Skwaam Bay, Adams Lake and 65 km north-northeast of Kamloops. The Rea Gold discovery zone lines about 1.2 km to the south (see 82M/4, Au 1).

Showings in this vicinity were held in 1970 as the MF 1-6 and K 41-46 claims by Barriere Explorations Ltd.; work included 105 feet of diamond drilling in 1 hole.

Some 2900 acres in the AR and HN groups were staked over this area in 1983 by J.A. Hilton and R. Nicholl following the discovery of the Rea Gold zone. The claims were subsequently optioned to Rea Gold Corporation who in turn optioned a 70% joint venture interest to Corporation Falconbridge Copper (CFC). Work over the larger property by CFC in 1984-85, included geochemical and horizontal loop electromagnetic surveys, trenching and drilling. Drilling of a geophysical anomaly led to the discovery of the new "Silver Zone" in late 1985.

Diamond drilling in 1986-87 indicated a reserve of 661 000 tons grading 32.1 oz/t Ag, 0.052 oz/t Au, 3.5% Zn, 1.7% Pb and 1.2% Cu (Northern Miner, March 7, 1988, p. B 13).

The company name (Corporation Falconbridge) was changed in 1987 to Minnova Inc. Joint venture participation is Minnova (70%) and Rea (30%). In addition Rea purchased a 5% net smelter royalty from J.A. Hilton.
