DESCRIPTION OF DEPOSIT

The Sooke Peninsula is underlain by a differentiated gabbroic intrusion of Tertiary age. Chalcopyrite, pyrite, pyrrhotite and magnetite are found in altered rocks along zones of shearing. major shear zones strike N43°E.

HISTORY OF EXPLORATION AND DEVELOPMENT

The Margaret Group is located in the northwest section of Sooke Peninsula, about 15 miles southwest of Victoria. The elevation ranges from 400 to 500 feet above sea level on the southern slopes of Mount Maguire. The property covers 99.08 acres, consisting of the Margaret, Copper King, Copper King Fraction and the Eureka claims. Prior to 1916 some development work was done by D. Campbell and associates. In 1916 the property was owned by A.R. Johnson and B.H. Jones and the following year it was bonded to O.B. Gerle and associates. By this time development consisted of open-cuts, stripping, and a shallow shaft. In 1918, the claims were Crown-granted to Messrs. Wm.H.R. and J.R. Collister, who worked them until 1931.

Late in 1947, F. Cooke, H.H. Huestis, F. Merryth, G. Griffith and associates relocated and took leases on mineral claims over the old copper properties on Sooke Peninsula. ground covered by the Margaret Group became known as the Huesti Zone.

Around 1970, Norlex Mines Limited leased 28 claims from San Juan Copper Co. Ltd., which is controlled by Canadian Javelin Limited. These claims include the Margaret and Willow Grouse (see 92 B/5, Cu 1), properties. A programme of diamond drilling was reported.

HISTORY OF PRODUCTION

Between 1917 and 1918, 559 tons of ore were shipped from the Margaret Group. This yielded 6 ounces of gold, 92 ounces of silver and 42,245 pounds of copper.
