DESCRIPTION OF DEPOSIT The property is underlain by the Upper Triassic Guichon Creek batholith; drill holes cut rocks of the Bethlehem and Bethsaida phases. Numerous veins of quartz, dykes of aplite, and dark basic "dykes" or inclusions of intruded rock occur. The mineralization generally occurs in the quartz veins in pegmatitic granite or grey quartz diorite, but in some cases molybdenite occurs as stringers of pure mineral in the wall rock. The mineralization consists of bornite, molybdenite, hematite, chalcopyrite, and covellite.		The Anaconda Company (Canada Ltd.) optioned the claims, along with several adjoining properties, late in 1963. Consider- able work was done in 1964 and 1965 in geological, geochemi- cal, and geophysical surveys, and diamond drilling. The company terminated its option at the end of 1965. Trojan Consolidated Mines Ltd. acquired control of B.X. Mining in 1965; the latter company was liquidated in 1975. Diamond drilling in 10 holes totalling 5,736 feet in 1969 outlined an area, known as the Ann No. 1 zone, some 1,200 to 2,200 ft. long and 600 to 1,050 feet wide, estimated to contain, to a depth of 400 feet, 45,000,000 tons averaging 0.26% copper and 0.005% molybdenite (Northern Miner, March 19, 1970). Further drilling was carried out in 1970 for a 1969-70 total of 10,370 feet in 16 holes. Reserves were reported at 47,820,000 tons averaging 0.27% copper (Northern Miner, June 20, 1974). Trojan Consolidated in April 1970 converted to a limited company under the name Trojan Consolidated Mines Limited. The property at this time consisted of 12 claims, the Ann 1- 10 and AM 13 and 15 fractions. The company name (Trojan) was changed in June 1972 to B.X. Development Limited. In 1976 the property, comprising 3 claims, was acquired by New Minex Resources Ltd.
