DESCRIPTION OF DEPOSIT/DESCRIPTION DU GISEMENT

The area is underlain by Middle Triassic and (?) older Bridge River Group (Ferguson Group) chert, argillite, phyllite and greenstone; minor limestone. Gold and silver are associated with an arsenopyrite vein with zinc in rusty zones. Zinc is associated with a silicified and hematized jasperoid zone. Pyrite, pyrrhotite and chalcopyrite are in a rhyolite breccia.

HISTORY OF EXPLORATION AND DEVELOPMENT HISTORIQUE DE L'EXPLORATION ET DE LA MISE EN VALEUR

The showings were explored in 1907 by means of pits, trenches and adits. In 1977 they were purchased by Quinto Mining Corporation in the Quinto Nos. 1 to VII claims. Subsequently they were re-located as the Q #1 to Q #10 claims and more claims were acquired by purchase in Cat #2 and Cat #3 and Hog #1 to Hog#4. Quinto built and improved access roads to the property and in 1980 re-evaluated the old workings. An airborne geophysical survey was carried out in 1981 followed by ground geophysics and geochemical surveys. In 1982 an IP survey, road building, and trenching were carried out. Channel sampling of old workings yielded 0.22 to 0.43 ozs Au/ton, 0.759 to 1.48 ozs Ag/ton, and 5.54 to 9.79% Zn.
