The Sunshine group of recorded claims was held in 1965 by Eugene and Frank Larsson and J.H. Henry. During the year about 700 feet of bulldozer trenching was done to expose bedrock. A jax Mercury Mines Limited optioned the Sunshine prop- erty in 1966 and staked additional claims in the Belle, A jax, and other groups. Geological and geochemical surveys, and 2,891 feet of diamond drilling in 32 holes was carried out in 1967. The company name was changed in 1971 to Ajax Resources Limited. During 1971 a geochemical soil survey (500 samples) was carried out over the Sunshine, Ajax, Belle, and Pro claim groups. The company name was changed in April 1973 to Pan-Ajax Resources Limited.
DESCRIPTION OF DEPOSIT The area is underlain by basic volcanic rocks, with minor shale and limestone, of the Triassic-Jurassic Takla group. Trenching exposes ferrodolomitized peridotite and serpentine with some green and grey schist. The main faults strike N60°W and dip about 90 degrees. The rocks are shattered and finely veined with a stockwork of quartz with some cinnabar. The exposed mercury mineralization occurs along the quartz stockwork and veins but may, where it is most intense, extend as dissem- inations through the rock.
