	IBUNE	HISTORY OF EXPLORATION AND DEVELOPMENT The property is located at about the 5,500 foot eleva- tion on the northwest side of "Hunter Basin" at the head of Cabinet Creek, 12 miles south-southwest of Telkwa. The Hunter claim was staked by Messrs. Hunter and Estib in 1903. Assessment work to 1914 was done in open cuts, and a 15 foot adit. The Tribune claim, adjoining the Hunter claim on the south, was located in 1911 by Chester Thoman, of Telkwa. Exploration work to 1914 was done in open cuts and a 115 foot long crosscut adit. In 1925 the property was held as the Riegle group, comprising the Hunter, View, and Ptarmigan claims, owned by A.O. Riegle, of Telkwa. A crosscut adit was driven 108 feet at that time. Some further work was done in 1929. The property was apparently part of a group of 68 claims, including the HB, AJ, Scout, and North claims, acquired by Hunter Basin Mines Ltd. in 1968 (see also 93 L/11, CU 4). Exploration work during 1969-1970 included electromagnetic, and geochemical soil and silt surveys.			
DESCRIPTION OF DEPOSIT The country rocks are predominantly red, purple, grey, and green Jurassic andesitic to rhyolitic tuffs, breccias, and flows, and minor intercalated sedimentary rocks. These rocks are intruded, about 1 mile south of the property by a porphyr- itic granitic stock, and locally by satellitic felsite dykes. On the Hunter claim the mineralization is disseminated along one thin bed of volcanic rock which strikes about east-west, dips 25° north, and has been traced for 300 feet along the con- tour. Bornite and specularite occur over widths of 6 inches to 3 feet, with local high-grade mineralization over widths of 8 to 12 inches. An average sample assayed: Gold, 0.04 ounce per ton; silver, 40 ounces per ton; copper, 25 per cent. On the Tribune claim a quartz vein 8 to 16 inches wide strikes northwesterly and dips steeply southwest. A sample across 12 inches assayed: Gold, trace; silver, 29.0 ounces per ton, copper, 1.8 per cent.
