## DESCRIPTION OF DEPOSIT/DESCRIPTION DU GISEMENT

The claims are underlain mainly by Jurassic-Cretaceous volcaniclastic rocks of the Hazelton Group. A lens of intercalated bioclastic, reefoid limestone mineralized with disseminations and minor fracture fillings of chalcopyrite is contained within the volcanic sequence. Minor amounts of bornite and chalcocite and traces of barite also occur in the limestone. A gabbro sill and small microdiorite stock intrude the layered rocks east of this lens.

The Red group of about 300 claims was owned by Canadian Superior Exploration Limited from about 1972. Exploration work in 1973 included a ground magnetometer survey over 75 line-miles, a geochemical soil survey (1,977 samples), trenching and 2,972' of diamond drilling in 9 holes on Red 3 and 5. This work outlined 5,500,000 tons at 0.50% Cu and 0.35 oz/t Ag (Windflower Mining Ltd, Prospectus, Feb. 1, 1985, p. 10). Additional work in 1975-76 included an induced potential survey over 19.2 km and 347 metres of diamond drilling in 3 holes on Red 7, 41 and 43.

Getty Mines, Limited held an option on the property for one year subsequent to 1976 and spent approximately \$100,000 in basic exploration.

Windflower Mining Ltd in June 1983 acquired the Red group (39 claims) from Canadian Superior Exploration.
