DESCRIPTION OF DEPOSIT

**PRODUCT** 

The deposit is a pyrometasomatic replacement of fractured Karmutsen greenstone at the contact of hornblende diorite of the Jedway stock. A small body of magnetite with some garnet and containing pyrite and chalcopyrite as veinlets trends westward from the contact and dips north about 40°. The body is some 80 feet long and 4 to 8 feet wide and runs about 1.5% copper, 0.10 oz./ton gold and 0.7 oz./ton silver.

HISTORY OF EXPLORATION AND DEVELOPMENT

This property consists of one Crown-granted claim, Lot 82, covering 40.63 acres. It is situated at 200 feet elevation about 1 mile southwest of Harriet Harbour on the southeast coas of Moresby Island. It is part of a large group originally held by J.S. McMillan (see Copper Queen, 103 B/6, Cu 3).

The showing was discovered around 1906 and Crown-granted to McMillan in 1909. It was explored by surface work and a 15-foo shaft. In 1908, 400 feet of drilling was done on this and the adjoining Modoc claim (103 B/6, Cu 4). Since then the only significant work was done in 1956 when Silver Standard Mines Limited drilled several short packsack holes totalling about 400 feet.

The property has remained in the McMillan family and in 196 was held by Paul McMillan.
