DESCRIPTION OF DEPOSIT

The prospect consists of a well-defined quartz vein 4 to 6 feet wide and traceable for about 700 feet. The vein contains sparse lenses and pods of pyrite that contain variable amounts of gold. Minor chalcopyrite is also reported.

Associated minerals or products of value - Copper, silver.

HISTORY OF EXPLORATION AND DEVELOPMENT

This property is situated on Pitt Island, on the west slope of Noble Mountain at 1,400 feet elevation.

In 1920, the Gold Bug 1-3 claims were staked by J.E. Halley of Prince Rupert. During that year, a small adit was driven across the vein.

In 1925 the property was restaked by J. Costello and C.O. Rowe as the Rowe group, including the Standard Watch, Canadian Girl and Rio Costello claims.

During the period 1925-1932, exploration work mainly involved extending and sampling of the small cross-cutting tunnel, and stripping and open-cutting along other quartz veins near the main showing.

Three samples taken from the tunnel assayed as follows:

- (1) Au - trace; Ag - 0.30 oz./ton; Cu - 0.5%;
- (2) Au - 0.02 oz./ton; Ag - 0.30 oz./ton; Cu - 2.4%;
- (3) Au - 2.04 oz./ton; Ag - 0.8 oz./ton.
