DESCRIPTION OF DEPOSIT/DESCRIPTION DU GISEMENT

Triassic volcanics, near the west margin of the Coast Plutonic Complex, are intruded by syenite and granodiorite stocks and andesite dykes. The copper showing consists of disseminated pyrite and sparse chalcopyrite in granodiorite and volcanics. Most drill core assays ranged from 0.1 to 0.2% Cu but one 5' section assayed 0.72% Cu.

HISTORY OF EXPLORATION AND DEVELOPMENT
HISTORIQUE DE L'EXPLORATION ET DE LA MISE EN VALEUR

The property is located some 10 km east of the Stikine River, easterly from the summit of Mt Scotsimpson, on the upper reaches of Split Creek at about 3,500' elevation.

Initial prospecting in the Split Creek area on behalf of K.J. Springer in 1942 located galena and chalcopyrite bearing quartz boulders. Highland Bell Ltd. staked claims and explored the copper showings in 1956-57.

Julian Mining Company Ltd, of the Wenner-Gren interests, in a joint venture with Anaconda American Brass Ltd staked the Ann 1-144 and Su 1-11 claims. Work in 1964-65 included geochemical, induced potential and magnetic surveys, bedrock stripping, and 7,200' of diamond drilling in 12 holes. Low copper values were encountered. Silver Standard Mines Limited staked the property in 1969 and held it for two years. Great Plains Development Company of Canada Ltd reportedly restaked the ground in 1974 and carried out a geochemical soil survey; gold values as high as 0.03 g/t were reported.

Teck Explorations Ltd staked 7 claims (99 units) on the property in 1981; the Split and Creek claims covered the copper showings. A gold showing was subsequently discovered on the adjoining Pay Dirt claim (see 104 G/4, AU 1).
