### DESCRIPTION OF DEPOSIT/DESCRIPTION DU GISEMENT

Mineralization is reported to consist of molybdenitebearing quartz veins cutting quartz monzonite over a considerable area. The mineralization occurs at the margin of the Tertiary Chutine quartz monzonite batholith in contact with Coast Range diorite and Permian limestone and phyllites. Molybdenite is found in quartz lenses, stockworks, and fracture fillings associated with zones of alteration and intense brecciation.

#### HISTORY OF EXPLORATION AND DEVELOPMENT HISTORIQUE DE L'EXPLORATION ET DE LA MISE EN VALEUR

This property, consisting of 79 claims, is located at the headwaters of Deeker Creek, which is an easterly flowing tributary of the Stikine River, about 48 miles southwest of Telegraph Creek.

Southwest Potash Corporation carried out a program of rock-trenching, sampling, and geological mapping during 1962. Work done during 1963 consisted of 4 diamond drill holes, totalling 196 ft.

Dictator Mines Ltd. acquired 39 claims which were a restaking, in August 1969, of part of the former claim group. Cerro Mining Company of Canada (1969) Ltd. acquired 70 claims surrounding. Dictator Mines reported geological mapping in 1970, and in 1971 the 39 claims were optioned to Cerro Mining. Work during 1971 included geological mapping, and 3,793 feet of diamond drilling in 5 holes on Ben 1, 10, and 14. The Cerro option terminated Dec. 31, 1971.
