DESCRIPTION OF DEPOSIT/DESCRIPTION DU GISEMENT
The formation consists of Pre-Permian gneiss and schist,
cut by quartz-porphyry and rhyolite dykes. Granitic rocks of
the Coast Intrusions outcrop less than a mile to the west. The
formation strikes northeast and dips to the northwest at
angles up to 15°. The veins for the most part are lens-shaped
and are practically everywhere conformable to the foliation
planes of the enclosing rock. The lenses are divisible into
two groups, formed at different times; of these the older
veins are badly broken and faulted. From the limited amount
of prospecting and assaying done it appears that the gold only
occurs in economically important amounts in the newer veins,
and that the older more broken lenses are practically barren.
The lenses vary in width from 2 to 24 inches and in length
from several feet up to 200 feet. The vein quartz carries
pyrite, galena, and chalcopyrite, with occasional free gold.

# HISTORY OF EXPLORATION AND DEVELOPMENT HISTORIQUE DE L'EXPLORATION ET DE LA MISE EN VALEUR

This property is located at the 3,600 foot elevation on the west side of Bighorn Creek about  $\frac{1}{2}$  mile downstream from the junction with Chicken Creek. The property was first staked in 1898, and having lapsed twice, was subsequently owned by several parties. In 1909 F. Lawsan & Associates staked the Big Horn group, consisting of the Big Horn, Little Bear, Gold Bird, Lucky Jack, Tyee, and Bertha claims. A one-stamp-mill was installed in about 1910 and small scale development work was carried on for several years.

Two adits, known as the North and the Little tunnels, have been driven 55 and 30 feet respectively, and some open-cuts and trenches have been made.

### HISTORY OF PRODUCTION/HISTORIQUE DE LA PRODUCTION

A recovery of over \$2,000 is reported to have been made from small tonnages of selected ore.
