The ore occurs in the form of bedded veins that conform in a general way to the stratification planes of the enclosing rocks, which here lie almost flat, and consist mainly of the dark, finely textured, clay-shale members of the Jura-Cretaceous Laberge group. The main vein is from 3 to 4 feet in thickness, and is composed chiefly of quartz and stibnite, with also some galena, and includes, as well, varying amounts of intercalated shale.

This property is located on the west side of Tagish Lake about 8 miles north of Graham Inlet. Two claims, the Lakefront & Antimony were located in about 1899 by Messrs. J. Johnson and C.B.
