DESCRIPTION OF DEPOSIT/DESCRIPTION DU GISEMENT

On the Fisher group two northeasterly striking mineralized zones appear to be present. One is a 6 inch kaolinized width in a porphyritic phase of the intrusion. It is mineralized with wolframite, arsenopyrite, pyrite, and tetrahedrite. A selected sample assayed: Uranium oxide equivalent, 0.006%; copper, 0.30%. A selected sample from the other zone assayed: Uranium oxide, 0.076%; thorium oxide, 0.005%; copper, 0.66%. No primary uranium minerals has been identified from any of the occurrences on the Fisher group.

HISTORY OF EXPLORATION AND DEVELOPMENT HISTORIQUE DE L'EXPLORATION ET DE LA MISE EN VALEUR

The Fisher Group is located at an elevation of about 6,200 feet on the southeast side of Mount Leonard, on the slope into the head of the west fork of Boulder Creek, 13 miles northeast of Atlin. The Purple Rose group lies about 4 miles to the northeast, at the head of the west branch of Cracker Creek.

Float submitted to the Barymin Company, Limited, by local prospectors late in 1953 was identified as high-grade botyroidal pitchblende. In 1954 the company engaged prospectors N.S. Fisher and O. Olsen to search for the source of the high-grade float. They failed to find any pitchblende but located a radioactive area and staked about 60 claims in the Fisher and Purple Rose groups in August 1954. During the summer of 1955 the company carried out stripping on showings on both groups.

Jason Explorers Ltd. held 6 claims in 1967 but it is not known if these were on the Fisher or Purple Rose showings.
