## DESCRIPTION OF DEPOSIT

The property is underlain by a mixed assemblage of sediments and metasediments of the Big Salmon Complex of Carboniferous, probably mainly Mississippian, age. Disseminated pyrrhotite, pyrite, and chalcopyrite occurs in actinolite-epidote gneiss, in May 1977 as the Arsenault 1-3 claims (60 units) by the AGDL quartzites and calcareous mica schists, and in calcite-quartz skarns where mafic dykes cut the gneiss-marble contact.

#### HISTORY OF EXPLORATION AND DEVELOPMENT

The property is located approximately  $4\frac{1}{2}$  miles east of Swift Lake and 7 miles south of the Alaska Highway at mile 753.

Copper mineralization in this vicinity was probably discovered in the late 1940's or early 1950's by Wilf McKinnon and associates while prospecting for Hudson Bay Exploration and Development Company Limited, but no follow up work was reported. Additional prospecting in the vicinity was done by Mr. McKinnon in the late 1950's or early 1960's as an independent prospector.

The Top group of 174 claims was staked by the late Mr. McKinnon, of Whitehorse, early in 1967 and optioned to the Karl Springer interests. Work carried out by the Husky Syndicate, in which Highland-Bell, Limited held a one-third interest, included geochemical soil and stream sediment sampling, geological mapping, and trenching. The option was abandoned in the summer of 1967.

Cyprus Exploration Corporation, Ltd., a subsidiary of Cyprus Mining Corporation of Los Angeles, optioned the claims from Mr. McKinnon in 1970. The option was subsequently transferred to another subsidiary. Bolivar Mining Corporation Ltd. Exploration work in 1970 and 1971 included geological mapping, airborne electromagnetic and magnetometer surveys, ground magnetometer and induced potential surveys, a geochemical survey, and 3,600 feet of diamond drilling in 4 holes. The option was subsequently given up and the claims lapsed.

Part of the area of the former Top claims was restaked in Syndicate of Whitehorse for Rebel Developments Ltd.
