DESCRIPTION OF DEPOSIT

The mineralization occurs in irregular bodies of skarn which lie within a broad band of light-grey marble. The marble strikes northeastward, dips steeply to the northwest, and is flanked on both sides by brown-weathering, impure quartzite. The two main showings lie near the northwestern margin of the marble and consist chiefly of sphalerite and galena in a gangue of yellowish-green garnet, wollastonite, and calcite. A trench 80 feet east of the adit exposes northeasterly striking steeply dipping skarn, mineralized skarn, and marble. A sample taken across 7 feet of mineralization assayed: gold, nil; silver, 2.5 ozs. a ton; lead, 8.7%; zinc, 19.5%. A selected sample of the chalcopyrite-bearing mineralization near the southern end of the trench assayed: gold, 0.02 oz. a ton; silver. 5.6 ozs. a ton; copper, 0.9%; lead, 16.9%; zinc, 32.8%.

Associated minerals or products of value - Lead, silver, copper, gold.

HISTORY OF EXPLORATION AND DEVELOPMENT

The Victoria claim is located at the 2,700 foot elevation on the east side of Inspector (Jarvis) Creek, about $\frac{1}{2}$ mile south-southwest of Copper Butte.

The Victoria claim was staked in 1905 and Crown-granted (Lot 903) to J.W. Burnham in 1910. Assessment work was done in open cuts, a 92 foot long crosscut adit in unmineralized marble, and, reportedly, 1 vertical diamond drill hole. The claim was owned in 1914 by Burnham, Kennedy, and Conway, and in 1931 by Richard Kennedy, of Haines, Alaska.
