DESCRIPTION OF DEPOSIT/DESCRIPTION DU GISEMENT

The formation consists of slaty and thinly interbedded argillaceous and calcareous sediments of the Slocan series intersected by several dykes of quartz porphyry. The workings explore mineralized vein quartz on O.K. Creek and on both sides of London Ridge. High-grade silver-bearing minerals, pyrite, galena, and zinc blende are in part distributed irregularly throughout the quartz and is part concentrated in small rich shoots.

HISTORY OF EXPLORATION AND DEVELOPMENT HISTORIQUE DE L'EXPLORATION ET DE LA MISE EN VALEUR

The Jo-Jo claim (Lot 1839) is located at the 5,000 foot elevation on 0.K. Creek, a northwest flowing tributary of Kane Creek some 4 miles northeast of Three Forks. The Miner Boy claim (Lot 4915) lies across London Ridge between elevations of 6,500 and 6,900 feet about $\frac{3}{4}$ of a mile southeast of the Jo-Jo claim. The Miner Boy claim adjoins the McAllister property on the east.

The Miner Boy group has been worked intermittently since 1893 when Messrs. Cummings, Adams, and Niven owned the claims. The Miner Boy claim was Crown-granted to C. Shoenberger and associates in 1902. In the 1930's the group consisted of the Miner Boy and Seattle Crown-granted claims and the Redruthite and Tip Top claims held by location; the group was owned by Messrs. Trenery, George, and Teir.

The Jo-Jo group, reportedly consisting of 4 claims, has been worked intermittently since about 1904.

In 1946 Trimetals Mining, Incorporated, of Spokane, Washington, acquired the Jo-Jo and Miner Boy claims, however, no work was done and the property was apparently transferred to Miner Boy, Incorporated, in 1947. During the year 16 feet of drifting was done in No. 1 adit and 158 feet of crosscutting in No. 3 adit.

No further work was done until 1966 when Vananda Explorations Limited formed the Banjo Syndicate to carry out exploration work on the property.

HISTORY OF PRODUCTION/HISTORIQUE DE LA PRODUCTION

In 1893, 3 tons of ore were shipped from the Miner Boy claim. From this ore 1,185 ounces of silver were recovered. A further shipment of 15 tons was reportedly made in 1910.

From 1904-1947, 144 tons of ore were shipped from the Jo-Jo group. From this ore 2 ounces of gold, 19,390 ounces of silver, 21,286 pounds of lead, and 1,164 pounds of zinc were recovered.
