No further work was done on the property and in 1942 the charter of the company was cancelled.			
DESCRIPTION OF DEPOSIT The showing occurs along the general contact between Lower Jurassic Bonanza andesites in the northwest and hornblende diorite in the southeast. The main showing is a gouge and breccia zone, 4 to 12 inches wide, containing scattered quartz-calcite lenses. The shear strikes north 52 degrees east and dips 80 degrees southeast.
