Pushing work ahead as fast as possible. Over 7 mi. of ditch 5ft wide bottom,7ft wide top and 24 in. desp. Brings water from Spanish lake. Employed 10 whites and 50 Chinamen. (B.C.Rep.1891 -.p.562).

On S. Fork rushing work on ditch with 8 whites and 25 Chinamen. (B.C. Rep. 1892 - p. 529).

Prospecting some gravel benches on Quesnel river, (N.Fork). Results not very satisfactory.

On S. Fork work carried on on large scale with big force of men. Work nearly completed and expect good results in spring of 1895.

On N.Fork company employed large force of men repairing ditch. By time they were ready the head of water got so light that they could not work to advantage therefore shut down for the season.

Started work early in the spring on Keithley point and were progressing favourably until a freshet carried away the bridge which conveyed the pipes across the river. This caused cessation of work, for the season. (B.C.Rep.1896 - p.516).

company owns a number of mining leases at different points and although a considerable amount has been expended in exploring these leases, not much has been discovered except during the past summer while exploring along Rose's Gulch. Good water supply by way of the 2-mi.ditch from Spanish lake while dumping facilities are excellent.
