Ore or substance **Scheelite**

Character of Deposit **Pegmatitic quartz vein mineralized with pyrite, chalcopyrite, galena, sphalerite, free gold, and scheelite, in a gangue of quartz, barite, and feldspar. Scheelite occurs as nodules up to 3" in diameter and as irregular streaks in the quartz.**

Country Rock **Chiefly granodiorite, with quartz porphyry and granite phases present. Granitic rocks hold large inclusions of schistose rocks and are intruded by aplite dikes.**

Associated minerals of value **Gold probably.**
