DESCRIPTION OF DEPOSIT/DESCRIPTION DU GISEMENT

The claims are underlain by limestone, buff dolomite, black cherty quartzite, and argillaceous limestone of the Lower Cambrian Atan group, which here strike east-southeast and dip steeply south. Small bodies of feldspar porphyry have intruded the sedimentary rocks along a zone striking N75°W. Adjacent to the intrusives, light and dark limestone beds are impregnated with galena, and some of the limestone has been replaced by barite and siderite. In the replacement zone, masses of barite and coarse-grained galena are common. Small amounts of pyrite, sphalerite, and copper carbonates accompany the lead sulphides. The mineralized zone is exposed by four trenches and some surface stripping over a length of about 600 feet.

At the lowest trench, galena is exposed in two sections, 9 feet and 5 feet wide, separated by 10 feet of mixed dyke rock and black limestone. A sample across the 9-foot section assayed: Gold, nil; silver, 0.7 oz per ton; lead, 6.8 per cent. A sample across the 5-foot section assayed: Gold, nil; silver, nil; lead, 10.6 per cent. In a trench 400' to the southeast a sample across 8 ft. of barite and limestone with galena assayed: gold, nil; silver, 0.2 oz/t; lead, 1.2%.

The Carlick group of four claims was staked by Beal Carlick, of Lower Post, in the summer of 1949. Moccasin Mines, Ltd., which held considerable nearby placer ground, optioned the property later in the year and staked additional claims on strike with the initial discovery. Exploration work by the company was limited to bulldozer stripping and trenching. The company charter was surrendered in 1950.

The showings were restaked as the Bill 1-6 claims, which were owned by Dresser Industries, Inc. in 1970; a geochemical soil survey (141 samples) was carried out during the year.
